# Position Opportunity: Program Specialist (Part-Time, Fully Remote)

## **Position Description**

IPFCC is hiring a part-time Program Specialist to support multiple projects and initiatives. IPFCC seeks an individual with an understanding of and commitment to patient- and family-centered care; patient and family engagement; and/or patient, family, and community partnerships.

## **Key Responsibilities**

- Provide support for qualitative research projects, including conducting interviews and focus groups, analyzing qualitative data, and writing research reports.
- Collaborate on the development of plain language resources to advance the understanding and practice of PFCC, including information briefs, toolkits, guidance documents, and reports.
- Provide support for virtual and occasional in-person learning events, including overseeing pre- and post-event logistics, directing online marketing efforts, developing slide decks, supporting presenters, and providing facilitation.
- Provide project management support, including development of project plans and timelines, outreach to and engagement of project partners, meeting facilitation, project reporting, and coordination of team members.
- Contribute to advancing PFCC awareness, understanding, and practice, including developing content for IPFCC's monthly newsletter, *Pinwheel Pages*; identifying articles and resources to share via social media; developing e-blasts about upcoming IPFCC events and projects; and contributing to IPFCC's online learning community, <u>PFCC.Connect</u>.
- Develop relationships with individuals and organizations to strengthen and expand IPFCC's network of partners and collaborators.

## Qualifications

- Minimum of 5-8 years of working experience, and a Bachelor's degree in a related field (e.g., public health, social sciences, public policy). A Master's degree in a related field is preferred, but not required.
- Knowledge of and demonstrated commitment to patient- and family-centered care, patient and family engagement, and the development of partnerships with individuals with lived experience. Familiarity with issues related to health equity preferred.
- Excellent writing skills, with an emphasis on plain language writing.
- Strong facilitation skills for leading and contributing to meetings and webinars.
- Strong organizational skills, attention to detail, highly motivated, ability to work both collaboratively and independently, and ability to prioritize tasks in a flexible environment.

#### **Additional Information**

- This is a part-time position (approximately 16-24 hours per week). IPFCC offers flexible hours as project work permits.
- IPFCC is a small, fully-virtual organization with a collaborative work environment. IPFCC prides itself on high-quality work that is responsive to the needs of our funders, clients, and partners.
